

## TECHNICAL DATA SHEET

### DESCRIPTION

**ProBond Agent** is a liquid additive to be used in the field for promoting better adhesion of the epoxy (ProPoxy) polymer resin to various surfaces like hard-troweled concrete, existing polymer floor coatings, ceramic or quarry tiles, or glazed blocks.

### PACKAGING

Available in 1 quart and 1 gallon containers.

### DOSAGE

For best results, add 1-2oz. by volume per gallon of mixed product.

### PRECAUTIONS

Since surfaces and coating formulations vary considerably, each application should be verified through testing before applying a subsequent polymer coating material.

Mechanical substrate preparation followed by cleaning and solvent-wiping may still be required to ensure strong adhesion to the surface.

Gloss surfaces must be dulled prior to a coating application with the adhesion promoter.

Surfaces must be clean and completely dry prior to the application of polymer materials containing the adhesion promoter.
